### 2011 Legislation Report / Updates \* & \*\*\*

#### A. Report, Discussion, Consideration and Possible Action on Board's Position on HB#2191 and HB #'s 2468 & 2469

The Executive Director, Donna Aune, reported on the following:

House Bill 2468 has not been assigned to a committee as of this date.

House Bill 2191 is a "vehicle bill" which holds a place until changes are made, a 'place holder'. This bill reduces the age limit and education requirements.

MOTION by Gary Begley to take an official position against House Bill 2191. MOTION SECONDED by Karla Clodfelter. MOTION CARRIED.

Karla Clodfelter reported that Representative Gail Griffin supports the reciprocity changes if we will revert back to an exam requirement for all reciprocity applicants instead of license for license that the agency now has in place.

**B. Report, Discussion, Consideration and Possible Action on Board's Position on All Pending 2011 Legislation Relevant to the Arizona State Board of Cosmetology.**

House Bill 2469 has been sent to the Employment and Regulatory Affairs Committee, the Appropriations Committee, and to the Rules Committee.

**Laser Use by Aestheticians \* & \*\*\***

**A. Discussion, Consideration, and Possible Action on Common Issues Regarding Certification Under the Cosmetic Laser and Injection Procedures Act, A.R.S. § 32-323 et seq.**

Gary Begley recommended forming a committee to pursue the issues of laser.

**B. Discussion, Consideration, and Possible Action on Forming a Laser Committee, Including Appointment of Committee Members**

MOTION by Karla Clodfelter to form a committee to research laser and report to the Board. MOTION SECONDED by Gary Begley. MOTION CARRIED.

Gary Begley, Karla Clodfelter and Cheryl Chelius expressed interest to become committee members.

Gary Begley appointed Karla Clodfelter and Cheryl Chelius to the committee which will be known as the "Laser Committee".

The first Laser Committee meeting is to be held on Monday, February 7, 2011 at Imaj Institute located at 8370 East Via De Ventura, Suite K-200, Scottsdale, Arizona, 85251 at 3:00 p.m.

Assistant Attorney General, Bridget Harrington, advised the Board that they could consider pursuing rulemaking in the area of laser curriculum.
