A. Discussion, Consideration and Possible Action on HB #2439 Reference Title: Cosmetology: Regulation:

- **A.R.S. § 32-501 (12) Definition of “School”/State Authorization of Cosmetology Schools – Title IV Funding/Arizona Cosmetology Schools**
- **A.R.S. § 32-516 Adding Cosmetologist with Aestheticians – Cosmetic Laser**
- **A.R.S. § 32-501(2)(c)(6)(e) – Removing “electrolysis”**
- **A.R.S. § 32-515 (D) Omitting Requirement of Application to Board for Reexamination**
- **A.R.S. § 32-510 (aesthetician), A.R.S. § 32-511 (cosmetologist), A.R.S. § 32-512 (nail tech) and A.R.S. § 32-531 (instructor) - Remove “23 Years of Age” Qualification**

Gary Begley reported that during the legislative committee meeting it was discussed A.R.S. § 32-501 (2)(c)(6)(e) removing “electrolysis” and after much discussion the committee has recommended that we should leave it as is.

MOTION by Karla Clodfelter to remove A.R.S. § 32-501 (2)(c)(6)(e) from HB #2439. MOTION SECONDED by Tammy Acton. MOTION CARRIED.

B. Discussion, Consideration & Possible Action on Barber Schools using Cosmetology School facilities: A.R.S. § 32-556 & A.R.S. § 32-501 (12)

- **Substantive Policy Statements**

Discussion occurred on the possibility of a school using a facility normally used by a cosmetology school when the cosmetology school is closed pursuant to the requirements of A.R.S. § 32-556.

MOTION by Karla Clodfelter to direct staff to work on a draft Substantive Policy Statement regarding the Board’s interpretation of A.R.S. § 32-556 allowing another school to operate in a cosmetology school facility only when the cosmetology school is closed and present the draft statement at the next Board meeting. MOTION SECONDED by Tammy Action. MOTION CARRIED.
