Karla Clodfelter, Chairman of the committee, reported that she and Executive Director, Donna Aune, recently had meetings with numerous State legislators to obtain support for our legislation. The legislators were given a packet about the Board to make them aware of the purpose of the agency and the kind of work done regarding public protection. This was received with a very positive reaction.

Recommendations made by the legislators include: separate the fees and policies into 2 separate bills, leave the Board member term limits at 3 years and remove the clause stating shall not serve more than 2 consecutive terms, and for reciprocity leave the wording as it is.

MOTION by Gary Begley to accept recommendations to separate fees and policy into 2 separate bills and to remove the clause for Board member shall not serve more than 2 terms and leave the terms at 3 years which would make A.R.S. §32-502 D. into C. MOTION SECONDED by Karla Clodfelter. MOTION CARRIED.

MOTION by Gary Begley to nominate Jessica Stall to the legislative Committee. MOTION SECONDED by Karla Clodfelter. MOTION CARRIED.
