3. Update Regarding Rule Exemption Request Pursuant to Executive Order 2018-02 for Omnibus Board Rule Package.

Executive Director Kim Scoplitte stated that on November 6, 2018, she, Deputy Director Theresa Bunch and Investigative Supervisor Irma Telles met with Emily Rajakovich, Director of Boards and Commissions regarding the Omnibus Board’s Rule Package. Emily Rajakovich shared some of her concerns and would like to see some changes in order for the rule package to be approved. The Executive Director explained that the agency could not bring these changes before the Board without her approval per the Executive Order 2018-02.

On November 7, 2018, Executive Director Kim Scoplitte stated that she sent an email to Emily Rajakovich, Director of Boards and Commissions thanking her for meeting with us to discuss the Board’s Rule Package and addressing her concerns to sections of the rules. Executive Director Kim Scoplitte stated that per Executive Order 2018-02 which states “A state agency subject to the Order, shall not conduct any rulemaking, whether informal or formal, without the prior written approval of the office of the Governor.” Executive Director Kim Scoplitte asked Emily Rajakovich Director of Boards and Commissions to please provide the written approval to engage in informal rulemaking for the limited purpose to discuss her concerns. Executive Director Kim Scoplitte stated as of this date no response has been received. Once a response is received, the changes will be placed on the Agenda for the Board’s consideration.
