Assistant Attorney General, Mona Baskin stated that in this case the complaint was issued on August 13, 2019, there was no response from the licensee which again is a salon which is an LLC and once time had elapsed for them to answer with attempts by Board staff to contact and resolve this case the State filed a motion to deem allegation admitted. The underlining complaint in this case dealt with significant sanitation violations but by the non-response by the licensee it is the State's position that those allegations are deemed admitted. In this case the LLC did not renew their license in January of this year and the State's position is that they have abandoned, they have no interest in being regulated by this Board, and there has been no contact, no evidence that they wished to continue to be regulated or remedy their sanitation violations.
