Amanda Ruff and Amber Crain were sworn in and stated the extensions were ordered on eBay, and the extensions last about five-weeks. Have customers that come in every month and a half to have the extensions removed and re-taped but, don't know what she does when she is at home. Investigator Joanne Ayotte testified this was a hair extension service, the complainant paid two-hundred upfront for the hair extensions and two-hundred for the extensions to be installed and within days the extensions fell out, complainant went back in to have them re-taped to have the extensions fall out again. Complainant Rachel Daddabbo was sworn in and stated that her mother had got her hair extensions for her graduation and paid Amber upfront two-hundred to purchase the hair, was told by Amber this was quality tape, hair which would last one-year and would need to be re-taped every three-months. Rachel Daddabbo stated had the extensions put in and within two-weeks they started to fall out, called Amber to see if she could re-tape them, which she did but they fell out within a week and a half. Rachel Daddabbo stated she went back a third time and the extension again fell out and asked for her money back.
