4. Review and Discussion: Professional Credential Services Update Regarding the Arizona Practical Examination Scoring Challenges.

Professional Credential Services (PCS) conducted an NIC Examiner Training on November 20th and 21st, 2021, to recruit licensed professionals to attend the two-day training; only seven showed up and participated both days. On the following Monday, November 22nd, two had already resigned. We also dismissed the on-site manager and some existing team members, leaving us understaffed to administer exams. Since then, Professional Credential Services (PCS) have hired a new on-site manager. She is working diligently and has come a long way to turn the team around. Professional Credential Services (PCS) see no scoring issues or inconsistency since the training and the new leadership. Professional Credential Services (PCS) also have not received any complaints under the new leadership. Since Covid, keeping good examiners committed to working has been an issue because no one wants to work. The complaints received by PCS and the Board staff recently came from the previous team prior to the new leadership.

5. Report, Discussion and Possible Action Regarding Proposed Changes to the Current Practical Examination.

The Chairman of the Board, Mr. Begley, stated the Board is very aware we had significant problems with the practical examination for quite some time. We had the conflict that was just discussed. Started in March of this year and ran through November causing a great number of people to receiving incorrect scores to have to be rescored to be significantly delayed in their corrections and being able to go to work. With all the work that Professional Credential

Services (PCS) done and PCS is a fine company and they worked hard and tried to do things but against some hurdles that are very difficult. We are still looking at a delay in getting practical examinations provided to our candidates of somewhere between 8 and 9 months. People are graduating from school today and looking forward to having a test administered in August. The Provisional license is how we patched that up to make that work. But we know the Governor asked that we stop issuing provisional licenses. So we've been looking for an alternative way to deal with this, something that provides a higher pass rate, something quicker to get to so that the candidates can have faster testing and faster opportunity to get into the workforce; and we came up with a pathway that can work for us.

Sean Colton with Prometric called in to discuss the difference in using Computer Base Training (CBT) program as opposed to the physical (in-person).

The Chairman of the Board, Mr. Begley, asked for any comments from the Board. Thomas Rough commented Computer Based Training (CBT) is a great idea. Primarily the public safety side that the practical is there for that and can be easily be tested without practical in-person.

Maria, Xytlo Beauty College commented that she is ok with the Computer Based Training (CBT).

Nickie, Scottsdale commented it's an excellent idea. Long overdue and students need this.

Cathy Koluch, The Studio Academy of Beauty, commented that she fully supports and definitely needs to do something to illuminate the backlog, Other states are doing this and have been very successful. Appreciate the effort on behalf of the Board to bring this to the table.

Testing centers available in Flagstaff, Goodyear, Phoenix, Tempe, Tucson, and Yuma. April 1, 2022, kick off for Computer Based Training (CBT).
