Kim Scoplitte Executive Director stated that the only bill that has been signed by the Governor is SB1149 Occupational and Professional Licensure; Notice. The other three bills have not changed. HB2029 Consolidation Barber Board/Cosmetology Board went to the Senate Caucus on 3/16/2021. HB2128 State Licensing; Fee Waiver went to the Senate for a second read on 3/9/2021 and HB2433 State Agencies; Cash Payment; Acceptance went to the Senate for a second read on 2/22/2021.

4. Report on Professional Credential Services (PCS) and National-Interstate Council of State Boards of Cosmetology (NIC) on NIC Nail Technology Theory and Practical Examinations Update for Remote School Overview held on March 22, 2021.

Alicia Aleman School Liaison stated that the School Overview was held on March 22, 2021 and that PCS went over sanitation/disinfectants, the simulating of disinfectants, PCS reiterated that sprays and aerosols are not allowed to be used in the examination, hand sanitizer must be used and to be in the original bottle and that all product must be labeled properly.

The Examiners Training was held on March 23<sup>rd</sup> and 24<sup>th</sup> and PCS discussed and reviewed the new Nail Technician Examination which will begin July 1, 2021.

Kim Scoplitte Executive Director stated that staff is looking into some options for getting the Infection Protection/Law Review Class online and Rosa Rodriguez is working with the agencies Shared Service IT and will share with the Board the options the agency might have.

Rosa Rodriguez stated that the agency is working with Ralph Bolvin who is the IT person at AZNET on getting the Infection Protection/Law Review Class online. The presentation will be in a PowerPoint version. The individual would fill out the registration form, pay the class fee and upload a government photo identification card and then the licensee would complete the class.

Rosa Rodriguez stated that there are two ways to set this up. The first would be that the individual would read through the PowerPoint slides and at the end of the class a certificate would be issued stating completion of the class with the date and the individual's name. The agency would receive proof of class completion via email.

The second setup would be for one of our investigators to record an audio on YouTube by reading the information on the slides at the end of the class a certificate would be issued stating completion of the class with the date and the individual's name and the agency would receive proof of class completion via email.

Joslyn Harris was sworn in and stated that she was not aware that anyone was unlicensed working in the salon and that we have braiders in the salon. Joslyn Harris stated

that on that day the salon was very busy, however she had addressed and corrected all issues.

Investigator Lisa Chavez testified that on November 20, 2020, Board office received an anonymous complaint alleging Joie Beauty Bar located in Phoenix, Arizona was allowing unlicensed individuals to perform cosmetology services without the proper license and are not following health and safety standards. On January 28, 2021, Investigator went to the salon and spoke with respondent Joslyn Harris who stated that they switched employees in November and possibly one of them made the complaint and that everyone here is licensed except the Braiders. Investigator Lisa Chavez informed the respondent that an inspection would be conducted and the following was found: Tiffany Presley was working on an expired Provisional license, business card that reads "JB lashes" which does not have the salon name or address for Joie Beauty Bar, lashes not enclosed, 2-shampoo bowls with hair in the filters and wet disinfectant not large enough for tool submersion.
