- Update on Case Status

Assistant Attorney General Bridget Harrington reported to the Board that the Court of Appeals heard the case on April 17, 2014, at McClintock High School; three judges asked questions of the attorneys. After the judges exited, students were also allowed to ask questions. The oral arguments went very well and it could take 6-months or longer to receive a decision.

**Proposed Legislation Relating to Arizona State Board of Cosmetology**

Karla Clodfelter reported that everything did pass and the Board has been continued for ten-years and on HB2439 there was an amendment placed on this bill which would have changed the age for licensure from 16 to 18.

Executive Director Donna Aune stated that Nick Simonetta and his staff got to work, Donna and her staff contacted all of the schools who totally stepped up in support and together we were able to stop this from passing with the amendment. HB2439 passed unanimously.
