3. Update Regarding Rule Exemption Request Pursuant to Executive Order 2019-01 for Omnibus Board Rule Package and Protection Consumers against Fraudulent Activities.

Executive Director Kim Scoplitte stated that the Rules Committee met on April 25th, the committee started reviewing the rules and discussed what the committee might be able to recommend in reducing burdensome rules. The committee has scheduled the next meeting which will be held on June 5th, at 9:00 a.m.

Executive Director Kim Scoplitte stated that as part of the Executive Order 2019-01 the agency was to provide a written plan on the agency complaint process and opportunities to improve to the Governor, the staff is pleased to share with the Board members that the report was submitted to the Governor on May 7, 2019.

4. Review, Consideration of Draft on Arizona State Board of Cosmetology Pamphlet Defining Salons and Salon Suite for Purposed Rule Making.

Executive Director Kim Scoplitte stated that during the Rules Committee meeting the Committee discussed looking into how other states define and address suite changes. Staff

looked into this and Deputy Director Theresa Bunch proposed the idea of using a pamphlet to share the information regarding the definition of suites and what is required when changing suites. However, suite changes need to be defined in rule first. The Board will need to review the pamphlet and provide comment. This may also be appropriate to be reviewed at the next Rule Committee meeting.

5. Report and Discussion of Proposed 2019 Legislation relating to the Arizona State Board of Cosmetology.

- SB 1328 Barbers; Cosmetologists; Licensure; Reciprocity; Apprenticeships
- SB 1401 Cosmetology; Licensing Exceptions
- HB 2569 Occupational Licensing; Reciprocity

Mona Baskin Assistant Attorney General stated that the Legislature is still in session and although these bills have been signed and directly impact the Board they will not go into effect until 90-days after the session ends. This will give the Attorney Generals' Office sufficient time to look at these bills and provide legal advice. As far as SB1401 the legislation is pretty clear that this is not going to be regulated by the Board.
