The Board made the decision that as of September 1, 2009, there will be no more salon or school license renewal reminders mailed out to establishments. This service has been a courtesy and not required by statute.

At a later date, the Board will look at the personal renewal reminders, this service is under statute.

The online service upgrade was completed as of May 27, 2009.

**E. Summary of Current Events.**

Due to the problems with licensee identification, the Board will look into newer technologies as used by other states currently such as photos on licenses and fingerprinting licensees.

The Deputy Director, Donna Aune, relayed to the Board that at an Executive Director meeting this week the Capitol alerted all agencies that due to the State's financial crisis the State government may

come to a halt and close at the end of this month if a budget plan cannot be put into place. Their advice was to be prepared for that possibility.
