## EXECUTIVE DIRECTOR'S REPORT

Executive Director Donna Aune reported that at the end of the fiscal year the Agency was able to give all of the uncovered employees a \$500.00 bonus which is part of the Personnel Reform Program that started in January of 2013. The Rules for the program came out in March of 2013, and the Executive Director Donna Aune and Deputy Director Nanci Kerns have been working on a Merit Raise Program for December 2013 which is based on a Bell Curve and would be from a 4% to a 2 1/2% raise for a period of 1-year.
