3. Report, Discussion and Possible Action on Rules Committee Meeting Held on June 5, 2019:

Brandy Wells reported to the Board members and stated that the committee has reviewed every section of the rules and have made significant proposed changes, the committee also reviewed a substantive policy statement approach to the recent bill 1401 that passed which would make it easier to comply with the changes to the law. The committee has updated older references, used different terminology and streamlined to make the rules more clear and hopefully the committee will be able to present the package to the Board before the August Board meeting to review and approve so that the Board can move these forward.

Mona Baskin Assistant Attorney General stated that SB1401 will be in effect August 27, 2019, and the rules committee has considered and discussed using a substantive policy statement and the statute is another exemption in subsection (14) for individuals to qualify for the exemption they will need to take a class given by the Board or Board designee and the Board currently has an Infection Protection/Law Review class which would satisfy that requirement and the individual would also be required to post out the services that are being provided. Additionally the salons are also required to post out services that are being provided.

Mona Baskin Assistant Attorney General stated that regarding HB2569 the Board will be getting advice regarding the interpretation of the residency requirement. The Board already has a swift method of endorsement from other states and countries currently in effect that the Board uses to issue licenses and this would be another option.

7. Report and Discussion on Disciplinary Parameters.

Executive Director Kim Scoplitte stated that the new disciplinary parameters were approved by the Board at the June 14th Board meeting and each of the Board members have been given the new parameters which are in the Board books.

8. Report and Discussion on (CTE) Career and Technical Education Summer Conference held at Lowes Ventana Canyon Resort in Tucson, July 16, 2019.

Theresa Bunch Deputy Director stated that on July 16, 2019, she was a guest speaker at the Career and Technical Education Summer Conference held at Lowes Ventana Canyon Resort in Tucson. Theresa Bunch Deputy Director stated that the agency has (12) CTE schools and it was very interesting to talk with the schools and with the Department of Education on how the agency can interact and work with them.

2. Report and Discussion on 90/10 Executive Directors' Meeting held on June 24, 2019.

Executive Director Kim Scoplitte stated that she and Deputy Director Theresa Bunch attended the 90/10 Executive Directors' meeting on June 24th, and Jason Joseph, Physical Security Manager ADOA/GSD spoke on Security, Situational Awareness, Active Shooter and Communication protocol. Jason Joseph spoke about active shooter training for agencies as well as Boards. Crystal Messner from General Accounting Office – Statewide Internal Audit spoke on GAO newsletter/Updates in which they want at least one individual from each agency to receive the newsletter/Updates and went over the Internal Control Self Assessments and Monthly Financial Reviews.

3. Report and Discussion on Budget Meeting held on July 11, 2019.

Executive Director Kim Scoplitte stated that on July 11th, she, Deputy Director Theresa Bunch, Administrative Services Officer I Kari Watkins, Susie Myers from ADOA Central Service Bureau and Damon Wellman Engagement Manager – ADOA Arizona Strategic Enterprise Technology met with Marshall Pimentel from OSPB the agency's new Budget Analyst. Discussed was needing to replace our current data system and the need to be appropriated for FTE's. It was a good meeting and we will meet again to further discuss the 2021 budget in more detail.

4. Report and Discussion on Agency Fiscal Year 2020 Budget and Fiscal Year End.

Executive Director Kim Scoplitte reported that the fiscal year end close went smoothly and the 2020 budget was approved and stated that Kari Watkins the agency's Administrative Service Officer I would speak further on this.

Kari Watkins, Administrative Service Officer 1, reported to the Board that due to system issues with AFIS, Arizona Financial Information System, the 2019 Fiscal Year end close is scheduled today, 07/19/19, so the agency does not have any of the year end reports available, and once the agency has received the reports, it will provide this information to the Board. Kari Watkins stated in the package provided to each of the Board members is the projections for FY20 which shows the appropriation load with the allotments for each quarter. The projections are based off of last fiscal year and it is the Executive Director's plan to update the Board quarterly with the actual expenses for each quarter. Kari Watkins also stated that in the package provided is the FY20 JLBC Appropriation Report of what was actually approved with details of the Cosmetology FY20 budget. Board Members will also see the supplemental amounts approved, which is called back of the bill adjustments, this is where the agencies are supplemented if there is an increase with expenses. Kari Watkins stated that for FY20 the agency received \$70,000 for the ongoing digitization project, and \$34,200 for the retirement fund. What was not approved is the \$15,000 for the GLS updates

to software, and \$15,000 for the mobile inspections/investigations, these items will be considered for the Fiscal Year 2021 budget.

Thuy Thi Bich Ho and Ky Pham the respondent's interpreter were sworn in and stated "Tina" Thuy Thi Bich Ho stated she holds an aesthetician license and the customer came in for an eyebrow wax and lip wax and that the customer's lips were already cracked, dried up and bleeding. "Tina" Thuy Thi Bich Ho stated that she gave the customer a tissue for the blood and only waxed above the lips. "Tina" Thuy Thi Bich Ho stated that she did not put any Aloe Vera on the client and that she did notice a little blood on the client, but "Tina" Thuy Thi Bich Ho stated she did not cause the customer's lip to bleed so she did not think about following the blood spill procedure. "Tina" Thuy Thi Bich Ho stated that the customer paid for the services and left, did not complain to the salon and there is no proof that that she caused the injury and we did not know anything until the investigator came by. "Tina" Thuy Thi Bich Ho stated that she has had her aesthetician license for 3-years, she went to school in Garden Grove in Orange County but does not know the name of the school.

Investigator Amber Bingham testified that on February 13, 2019, Board office received a complaint from Roxanne Glass stating that she went to Darian's Luxury Nails & Spa in Coolidge, Arizona for a manicure, pedicure and facial wax services and stated that and when the wax was removed there was skin that was ripped off from her lip instead of above her lip and when the complainant was leaving a client told her that she was bleeding.

Investigator Amber Bingham stated that on February 14, 2019, she met with complainant and confirmed the date of service was February 12, 2019, and the name of the licensee who performed the service was "Tina" Thuy Thi Bich Ho. The complainant stated when she entered the room she noticed that the paper on the bed looked used not fresh, there were dirty towels, no powder was applied before the waxing service however licensee did apply powder after the service. Complainant noticed a difference in the wax temperature when the wax was applied from one eyebrow to the other which was hot and then to the lip. Complainant stated after realized she was bleeding "Tina" took her back to the room and a green aloe gel was applied with a cotton ball. Complainant stated that her skin was burning so "Tina" used a wet cotton ball to remove the gel.

Investigator Amber Bingham stated that on February 19, 2019, she went to the salon "Tina" Thuy Thi Bich Ho was not in at the time of investigation and spoke to Ky Pham the front desk manager and gave him the information and asked him to contact her. Investigator Amber Bingham stated that she proceeded to check licenses, health and safety and infection protection control and found the following: Both establishment licenses were inactive, Owner "Tina" Thuy Thi Bich Ho aesthetician license was inactive, no tuberculocidal concentrate, wax muslin not covered and aesthetic bed lined with used paper.

Investigator Amber Bingham stated that she received a response from "Tina" Thuy Thi Bich Ho stating that prior to the service her lip was already dry, cracked, bleeding and only used a tissue to soak up the blood.
