Kim Scoplitte Executive Director stated that staff provided to the full Board in their board packet to review, the June 5th and July 8th rules committee meeting minutes so that the Board could review what the rules committee has been working on, also the draft of the R4-10-112 Infection Control and Safety Standards and the proposed rule changes that the rules committee is recommending to the Board and should this be the position of the Board to move forward with the changes there would need to be a motion.

Gary Begley Chair stated that he had read over all of changes and found them to be consistent in what the committee was working on and has no objections to them.

Jenna Bentley stated that what the committee’s main goal was to bring clarification to some of the most vague areas such as salon suites, revised language regarding signage not required to be affixed to the outside just in an conspicuous place, attempting to bring clarification for individuals running these suites and help give more discretion to our inspectors.

Other areas the committee worked on were the unintentional non-compliance with sanitation. The committee was able to clean up some language which was decades old or just out of date and with the new technology which makes it confusing to understand how it complies today. A Substantive Policy Statement was drafted for the two pieces of legislation that recently passed.

There are other areas the committee wants to take a look at such as schools and curriculum which will take a little time to go through to get the language correct. However

what the committee was able to put forward is a great step forward and will help in the immediate future.

Kim Scoplitte Executive Director stated that she and Theresa Bunch Deputy Director met with Willie Higgins from DES on July 23, 2019, and went over the Arizona Apprenticeship Program which will include 3,000 hours of training, supplemented by the minimum required 250 to 288 hours of related instruction. The program should take 1-1/2 years to complete and the apprentice will earn a wage while they train.

Willie Higgins stated that the mentors and salons who wish to be a part of the program would contact DES and then DES would send a list of individuals and salons for the agency to verify that they are in good standing with the Board and send back to DES.

Kim Scoplitte Executive Director stated that staff has drafted a Substantive Policy Statement regarding SB1401 for the Board to review. There is also a new application for the Infection Protection/Law Review Class a requirement to attend the class associated with this new law change that will allow the agency to keep track and report back to the Governor's Office.

Inspector Margarita Amparo testified that on November 9, 2018, she conducted an inspection of Locks and Lases located in Glendale Arizona, and found the following: Establishment suite was unlicensed, no large wet disinfectant set up and lash supplies, combs and spoolies were not enclosed.
