There was a lot of talk of deregulation, some states have been fighting this for two/three years and there were four states up for deregulation last year that never got out of committee because there were so many licensees that showed up that want regulation.

Gary Begley reported that there are thirty eight states now using the standardized test so we've made good progress. He also reported that there is a strong movement to create a central information source for boards, such as information on licensees, sunset, day to day problems etc., going to see some major changes this year.
