Gary Begley, Board Chair asked staff if they had changed their license to nail technology.

Theresa Bunch, Deputy Director stated that they did submit an application to change to a nail technology but came back and said that they were going to keep it as cosmetology.

Investigator Lisa Chavez stated that she did an inspection of Century Spa Nails on January 8, 2020, and stated they did correct some items. Nguyen had two delinquent licenses, soiled tools, not properly disinfecting pedicure spas. Investigator asked how they clean and disinfect the spas they said they use Awesome cleaner when investigator asked the question again they said the owner comes in after the salon is closed and disinfects the tubs. Investigator educated them on how to properly clean and disinfect the spas.

Investigator Lisa Chavez stated that they were no longer re-using pumice stones and they are using the small individual cups with lids to put the masks and scrub product into.
